EDITED AS UNDERLINED:
USE OF RED FLAGS ON MAIN AND HIGH POWER RANGES
HOT RANGE? COLD RANGE?

For safety of ALL users of the Main and High Power Ranges we are implementing the use of the RED flags positioned on both ranges. What does this mean? When live fire is active on either of these ranges you must have the RED flag up. When you have communicated and agreed with others on the range to call the range cold, you or another designated range user will take the RED flag down until such time it is determined to have the range go hot again. When the respective range is a cold range, all persons present on that range **MUST** remain back from the tables/benches unless you are going down range to change out/place targets. Absolutely no handling of firearms is permitted.

The RED flags are located in the middle of each range.

ONLINE RENEWALS!

You can now renew online! Please follow the steps below:

1. Go to tontorimsportsclub.org (NOT .com) and press the “RENEW” button at the top of the page and enter your email address.
2. Press the “forgot password” to generate a password for you—this can be changed to whatever you want later.
3. Double check that your mailing address is correct.
4. Review the Orientation and Range Safety Rules and click at the bottom of the page to acknowledge that you agree and understand ALL of this information. You will then be directed to the online payment system.
5. Enter your credit/debit card data into the secure system. Your gate card will automatically be updated.

Proposed Bylaws Changes**

The current Bylaws dated January 2021 are mislabeled version “7.0”. Should be version “8.0”.

Along with cleaning up the Bylaws format, spelling and grammatical corrections, proposed changes to the Bylaws dated January 2021 are as follows:

Article III – Membership

PRIOR VERSION:

Any citizen of the United States may become a member of the Club by; a) completing an application for membership and subscribing to the NRA pledge (below); b) completing a signed range orientation form under the supervision of a Range Safety Officer and; c) payment of annual dues. Upon receipt of the above the Membership Secretary shall verify the application and range orientation. RSO issues Membership Card and Gate Card to the applicant. The Gate Card remains the property of TRSC and must be returned if membership is not renewed.

PROPOSED CHANGE:

Any citizen of the United States may become a member of the Club by: a) completing the online Membership Application and subscribing to the NRA pledge (below); b) acknowledging the Range Orientation form accompanying the Membership Application; and c) payment of annual dues. Upon receipt, review and acceptance of the completed Membership Application and Range Orientation form, the Membership Secretary shall immediately issue and mail to the new member a gate card for access to the Club facility known as Jim Jones Shooting Range (the “Range”). The gate card remains the property of the Club and must be returned if membership is not renewed.

Article IV – Dues

PRIOR VERSION:

b) Membership Renewal statements shall be sent to each member by mail in early December. Payment by January 1^o is expected for membership renewal.

PROPOSED CHANGE:

b) Membership Renewal statements will be sent to each member by email as early as November. ***Payment by January 1 is expected for membership renewal.***

Article V – Meetings

** Regular Meeting changed to “General” here and elsewhere in Bylaws where necessary. **

c) General Meeting held on third Tuesday...

d) Special Meetings. Notice of Special Meeting to be sent by email vs. United States Mail.

Article VII – Duties of Officers

NOTE: Article number mislabeled as Article VI corrected.

MEMBERSHIP SECRETARY PRIOR VERSION:

d) Membership Secretary the Membership Secretary shall: maintain a record of all Club members and their current addresses and be responsible for processing all applications for membership in the Club. The Membership Secretary shall also be responsible for the collection of dues and remit same to the Treasurer. Membership Secretary will be responsible for the assignment and update of all active membership and Range Gate Cards. All monies for club membership dues shall be given to the Membership Secretary for processing. Shall also be responsible for gate cards, reassurances for lost membership cards at time of membership or renewal. At the end of his/her term the Membership Secretary shall deliver to his/her successor in office all Club property, records and funds in his/her possession.

MEMBERSHIP SECRETARY PROPOSED VERSION:

e) **Membership Secretary** – The Membership Secretary shall: (i) maintain a record of all Club members and their current addresses and email addresses; (ii) be responsible for processing all Membership Applications; (iii) be responsible for the collection of dues and remit same to the Treasurer; and (iv) be responsible for the assignment and update of all active membership range gate cards.

At the end of his/her term the Membership Secretary shall deliver to his/her successor in office all Club property, records and funds in his/her possession.

RANGE MANAGER PRIOR VERSION:

g) Range Manager:

The Range Manger will have the responsibility for the overall maintenance of the Shooting Range facilities. Keep records of all equipment maintenance, range and storage keys, authorized equipment operators, boundary reports and facilities condition. Interface with sanitation vendors for necessary services. Interface with any contractors on maintenance problems related to Range Gate, facilities and equipment maintenance. Enlist and schedule club members for specific range duties. At the end of his/her term the Range Manager shall deliver to his/her successor in office all Club property, records and funds in his/her possession.

RANGE MANAGER PROPOSED VERSION:

f) **Range Manager** – The Range Manager shall: (i) have the responsibility for the overall maintenance of the Range; (ii) keep records of all equipment maintenance, range and storage keys, authorized equipment operators, boundary reports and Range’s condition; (iii) interface with sanitation vendors

for necessary services; and (iv) interface with any contractors on maintenance problems related to the Range gate, facilities and equipment maintenance.

At the end of his/her term the Range Manager shall deliver to his/her successor in office all Club property, records and funds in his/her possession.

Article VIII – Elections

PRIOR VERSION:

- c) A Nomination Committee shall be established consisting of two members from the Board of Directors and two members selected from volunteers from the Club's membership. The duties of the committee will be to solicit and receive nominations for Club officers. Upon receiving a nomination, the committee shall contact the nominee and verify his/her acceptance of the nomination. Every regular member shall have the right to nominate a candidate for any office or position to be filled. Nominations may be submitted in writing if they are received by the Nominating Committee no later than January 1st of the election year. The results of the committee's proceedings shall be presented to the membership at the Club's February meeting.

PROPOSED VERSION:

- c) A Nomination Committee shall be established, in early fall of the upcoming election year, consisting of two (2) members from the Board of Directors and two members selected from volunteers from the Club's membership. The duties of the Nomination Committee will be to solicit and receive nominations for Club officers. Upon receiving a nomination, the Nomination Committee shall contact the nominee and verify his/her acceptance of the nomination. Every regular member shall have the right to nominate a candidate for any office or position to be filled. Nominations may be submitted in writing if they are received by the Nominating Committee no later than December 1st. The results of the Nomination Committee's proceedings shall be presented to the membership at the Club's December meeting.

PRIOR VERSION:

- h) Ballots shall be mailed out to all active members by January 15th of the election year. All ballots mailed to the Club must be received on or before February 15th of the election year. Ballots that are not mailed in to the Club may be presented and collected at the annual meeting.

PROPOSED VERSION:

- h) Ballots shall be emailed to all active members by January 15th of the election year. All ballots mailed to the Club must be received on or before March 1 of the election year. Ballots that are not mailed to the Club may be presented and collected at the Annual Meeting.

Article IX – Amendments

PRIOR VERSION:

- a) These By-Laws shall not be suspended, but may be altered or amended by a two thirds (2/3) vote of members present at final meeting and voting at a regular Club meeting or a special meeting called for that purpose. All proposed changes shall be in writing and: 1) signed by at least twenty (20) members in

good standing or 2) submitted by a majority vote of the Board of Directors. Such proposals shall be presented at least two (2) regular meetings previous to the one in which final action is taken.

PROPOSED VERSION:

- a) These Bylaws shall not be suspended but may be altered or amended by a two-thirds (2/3) vote of members present at the third and final reading and voting at a General Meeting or a Special Meeting called for that purpose. All proposed changes shall be in writing and: (i) be signed by at least twenty (20) members in good standing; or (ii) be submitted by a majority vote of the Board of Directors. Such proposals shall be presented to the membership beforehand at least two (2) General Meetings prior to the meeting in which final action is taken.
